
Town/Village of Lowville Planning Board Regular Meeting Wednesday, April 28, 2021 7:00 P.M.

- 5. New Business:
 - a. **Application SPA2021-1**, submitted by **SMSA Architectural Services on behalf of Elaine Nolt**, requesting site plan review approval to expand a retail business in accordance with Town of Lowville, Chapter 250, Article X in a CB-R Zone. The parcel is owned by Elaine Nolt, located at 7189 State Route 812, Town of Lowville New York, tax parcel number 195.00-03-03.000.

The application and its contents were reviewed by the board with the Site Plan Review checklist completed. Mr. Steiger provided the board members with conceptual stormwater information. There was discussion regarding the drainage on the portion to be blacktopped. There was discussion that it will be necessary for Mr. Steiger to supply the board what type of vegetation will be used as a buffer on the State Route 812 side of the parcel.

The board reviewed and completed the SEQR short form parts 2 and 3.

A MOTION was made by Jeff to deem the application an unlisted action and issue a negative declaration for environmental significance. The motion was seconded by Henry. All members present in favor. Motion carried.

A MOTION was made by Rebecca to deem Application SPA2021-1 complete, forwarding the application to the County Planning Department and scheduling the public hearing for May 26, 2021. The motion was seconded by Henry. All members present in favor. Motion carried.

b. Application SPA2021-1, submitted by Tug Hill Artisan Roasters on behalf of North Country Transitional Living, requesting a special use permit which includes site plan review approval to convert a structure to mixed use development in accordance with Village of Lowville, Chapter 201 Articles XI and IX in a VC Zone. The parcel is owned by North Country Transitional Living, located at 7514 South State Street, Village of Lowville, New York, tax parcel number 212.11-07-29.100.

There was discussion with the applicant regarding certain items supplied for A through Y of the application. The application and its contents were reviewed by the board with the Site Plan Review checklist completed. There was discussion regarding traffic circulation on the parcel.

The SEQR short form was reviewed with parts 2 and completed by the board.

A MOTION was made by Henry to deem the application an unlisted action and issue a negative declaration for environmental significance. The motion was seconded by Rebecca. All members present in favor. Motion carried.

A MOTION was made by Lisa to deem Application SPA2021-2 complete, forwarding the application to the County Planning Department and scheduling the public hearing for May 26, 2021. The motion was seconded by Jeff. All members present in favor. Motion carried.
