## **ATTORNEY**

-Cannabis Opt-Out Legislation: Supervisor Schell reported receiving copies of documents from Mountainview Prevention following the public hearing on LL#1-2021. He stated that if a public referendum is held that it would include both town and village residents. Attorney Meier stated that in order to have a referendum, a petition must be filed within 45 days of the local law being enacted. Petitions would need to be submitted to the Town Clerk and include the signatures of 10% of people who voted in the last election for Governor in the Town of Lowville. Attorney Meier will research more into the requirements of the actual petitions.

Attorney Meier briefly reiterated that the "opt-out law" covers cannabis retail dispensaries and on-site consumption sites only. It does not address personal possession, use or growing. After discussion, the following resolution was presented.

<u>Motion</u> by Councilman Mullin seconded by Councilwoman Laribee to adopt **Resolution No. 17-2021**, "Adopting Local Law #1-2021 " A local law to opt out of allowing cannabis retail dispensaries and on-site consumption sites as authorized under Cannabis Law Article 4".

WHEREAS, the Town Board of the Town of Lowville, held a public hearing at a Town Board meeting on May 20, 2021 at 10:00 a.m. for Local Law No. 1-2021; and

THEN THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Lowville adopts Local Law No. 1-2021 known as "A Local Law to Opt Out of Allowing Cannabis Retail Dispensaries and On-Site Consumption Sites as Authorized Under Cannabis Law Article 4"; and

BE IT FURTHER RESOLVED, that this law is subject to permissive referendum.
