#### **JUSTICE**

Judge Coffman feels that he is being inundated with paperwork in the Court. He would like to hire an assistant Court Clerk, part-time to help catch up the backlog. There is \$400 remaining above the Clerk funds allocated in the 2021 budget, that Judge Coffman would like to use to fund a new assistant Court Clerk for the remainder of the year. He also discussed with the Board, the need to have a part-time and a full-time Court Clerk after the Village of Lowville Court dissolves. He is also concerned that he will not be able to find help for \$13.50/hour. Judge Coffman will contact the Office of Court Administration to find out what to do if he cannot find a new clerk. He would like the Board to create a new Part-time assistant Court Clerk position at a rate of compensation of \$15.00/hour. Councilwoman Birchenough would like Judge Coffman to come up with a job description.

<u>Motion</u> by Councilman Ross, seconded by Councilwoman Birchenough to adopt **Resolution No 53-2021**, "Creating the Position of Part-Time Assistant Court Clerk".

WHEREAS, the Town of Lowville Court is in need of additional support staff;

BE IT RESOLVED, that the Town of Lowville will create the position of "Part-time Assistant Court Clerk" through 12/31/2021 at a rate of compensation of \$15.00/hour, not to exceed \$400.00.

### **BUDGET OFFICER/BOOKKEEPER**

Accountant Scott Lawrence reviewed the financials through 10/31/2021 with the Town Board.

There was a brief discussion about the water & sewer Village/Town billing comparison.

### **RACOG**

Mickey Dietrich gave a brief update on the happenings at the Tug Hill Commission. The Tug Hill Commission Local Government Conference 2022 will be held at Turning Stone Casino & Resort. RACOG has approved the Town of New Bremen to join RACOG, but they cannot join the joint cooperative ZBA at this time because the ZBA is full. May start a second co-operative ZBA for just Lewis County.



#### **COMPREHENSIVE PLAN**

The Comprehensive Plan Committee must hold a public hearing on the proposed new comprehensive plan. A copy of the plan is available at the Town Clerk's office. After the Committee's public hearing, the Town Board and Village Board will need to hold a public hearing within 90 days. Supervisor Schell will contact Alaina Mallette of the Tug Hill Commission in regard to setting a date for the Committee's public hearing.

### **NEW BUSINESS**

### FIRE CONTRACT

The Town Clerk has received the fire contract for 2022 with the Village of Lowville and the Lowville Fire Department. A public hearing will need to be set.

<u>Motion</u> by Councilman Mullin, seconded by Councilman Ross to adopt **Resolution No. 54-2021**, "Setting the Public Hearing for the 2022 Fire Contract".

### **#3 WIND PILOT**

Supervisor Schell reviewed the proposed PILOT agreement with the Board. Discussion followed.

#### **OLD BUSINESS**

## **HEALTH INSURANCE**

Supervisor Schell proposed a change to the calculation for employee contribution for current/active employees who are non-highway and/or not covered by the Teamsters Insurance plan. After discussion, the following resolution was presented.

<u>Motion</u> by Councilman Mullin, seconded by Councilman Ross to adopt **Resolution No. 55-2021**, "Amendment to Health Insurance Chart".

ADOPTED - AYES – Birchenough, Mullin, Ross, Schell, Virkler NAYS – 0

WHEREAS, the Town of Lowville has heretofore adopted a policy with reference to payment of part or all of the cost of health insurance premiums for employees of the Town, which policy was adopted on October 15, 1992; and

WHEREAS, the Town of Lowville did thereafter amend such policy by Resolutions adopted on the following dates:

October 24, 1994 January 15, 1998 August 21, 2003



November 9, 2005 and February 15, 2007; and

WHEREAS, subparagraph 2 of the first "RESOLVED" paragraph of the November 9, 2005 Resolution makes reference to "any newly elected, re-elected, appointed, reappointed or hired official who becomes employed by the Town of Lowville after January 1, 2006..."; and

WHEREAS, this Resolution should not affect any current Town of Lowville retiree or any member of the Teamsters Union Insurance; then Therefore,

BE IT RESOLVED, that the Town of Lowville Health Insurance Policy Chart be amended as follows:

The Town of Lowville Share for all active employees, regardless of when hired shall be 75% of the premium. The Employee shall be responsible to pay 25% of the premium. And, Be It Further,

RESOLVED that this Resolution be adopted by the Town Board of the Town of Lowville this 18<sup>th</sup> day of November, 2021 and shall take effect January 1, 2022.

## Year End/Re-Organizational Meeting

Supervisor Schell stated that the Board will need to set a date for a re-organizational meeting to conclude any business for the year 2021 and organize for the year 2022, along with any additional business that may come before the Board. The Re-Organizational/End of Year meeting will be held on December 30, 2021 at 9:30 a.m. at the Town of Lowville Municipal Building. Town Clerk will advertise in the Journal & Republican, on the Town's website, Town Clerk Bulletin Board and on Linkinglewiscounty.com.
