Justice

Justices Philippe and Eaves would like to apply for a JCAP grant to purchase new desks, bookshelves, laptop docking stations and monitors. The request will not exceed \$5,000.00. After brief discussion the following resolution was presented.

Motion by Councilman Farney, seconded by Councilman Monnat to adopt **Resolution No. 54-2024, "Support for the Justice Court Assistance Program Grant Application"**.

WHEREAS, New York State has established the Justice Court Assistance Program to enable Towns and Villages to apply to the Chief Administrative Judge for a grant of state funds to assist in the operation of the Local Justice Courts, and

WHEREAS, the Town of Lowville recognizes the need for additional storage, now, therefore be it

RESOLVED, that the Town of Lowville authorizes the Town of Lowville Court to apply for a JCAP grant in the 2024-25 grant cycle up to \$5,000.
